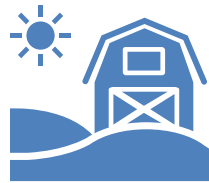

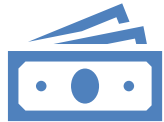

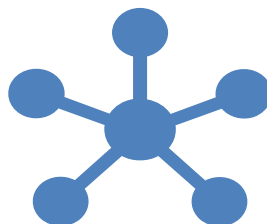
# Recommendations for UK Practice
